The selectee will assist the unit medical provider with first line medical care of unit team members in both garrison and tactical operations, this includes from initial trauma stabilization, on-going field trauma care, and CASEVAC to definitive care. Operates emergency medical and other vehicles. Loads and unloads litter patients. Participates in contingency or disaster field training, exercises, and deployments. Obtains and maintains unit supplies/areas. Disposes of medical waste. Maintains outpatient medical records. Screens medical records for deploy ability and other medical administrative requirements. Prepares and submits administrative reports. Serves as the alternate medical supply accountability officer where he/she oversees the management, security, maintenance, and control of medical material. If selected, the HCNCO must work a minimum of twenty percent of their work week in a pre-hospital or hospital trauma/emergency setting as per CNGBI 500-3 para 9-1 (2)(b).
