SECTION III: Qualification Requirements (Upon selection for this position, individual must possess or initiate a National Agency Check with Inquiries (NACI) background investigation. A favorable determination based upon investigative results is mandatory for this position. Failure to meet these requirements will result in termination of employment.)

Minimum grade WO1, O1; maximum grade CW3, O3.

CD Point of Contact

- 1. Must not be under any current Suspension of Favorable Personnel Actions (FLAGS)
- 2. Applicant must maintain appropriate level of physical readiness and pass the appropriate service fitness test IAW service regulations.
- 3. Must have an Army issued driver's license or be able to obtain one by the start of the duty position. To include a valid State issued driver's License.
- 4. Must be worldwide deployable with no duty limiting conditions to include but not limited to: temporary profiles greater than 14 days, dental readiness class 3, permanent profile indicating a MAR2, permanent profile indicating a MEB, permanent profile indicating a non-duty related action is needed, and no physical restrictions.
- 5. Must have a non-expired Government Travel Card (GTC) or be able to obtain one by the start date of the
- 6. Must be comfortable speaking in public and have experience giving presentations to large and small groups IAW with TRADOC 350-70.
- 7. Must be able to work without direct supervision.
- 8. Must be a self-starter, responsible, dependable, and well organized.
- 9. Must have computer knowledge and skills.
- 10. Must have experience with AR 25-50.
- 11. Must be an Army Aviator, rotary wing category qualified and current in UH72A.

The Soldier must not have served on any combination of operational support orders for more than three years out of the preceding four years. Applicant must not serve more than 17 years of Active Federal Service as a result of this duty. The Soldier/Airman must not be able to qualify for sanctuary as a result of the duty unless a waiver is approved prior to the publication of the order.

SECTION IV: Placement Factors

Applicants should demonstrate through prior experience, education and training the following:

- 1. Completion of Counterdrug Doctrinal Training Course (Online) within 30 days of acceptance of CD orders.
- 2. Completion of Aviation Integration Policy Course (AIPC) within 6 months of CD Orders.
- 3. Possess a favorable National Agency Check (NAC) and be able to obtain a Secret security clearance for the duty position of assignment (if required).
- 4. Experienced in the use of Case Management or equivalent type of database.
- Preferred experience of at least 750 flight hours.
- 6. Law enforcement familiarization and coordination experience is preferred.
- 7. Preferred at least 1 year experience operating MEP system in RL1 status.

Selectee may be subject to uncommon tours of duty, recall to the workplace, and irregular hours. Shift work may be required. Selectee will be required to attend Individual Drill Training (IDT)/Annual Training (AT) periods while on this tour. Must meet medical retention standards. Permanent Change of Station (PCS) funding for duty greater than 139 days is subject to approval by the respective program manager.

As a Counterdrug Pilot, your primary duty will be in support of Federal, State & Local Law Enforcement Agencies (LEA) by providing an aircraft and mission set as requested.

A brief description of these duties includes, but is not limited to:

- 1. Reports directly to the CD AV OIC and performs assigned mission category duties as directed.
- Focuses on being proficient in MEP Aircraft Camera TTPs.
- Serves as Pilot in Command (PC) / Pilot (PI) on mission flights.
- Initiates, develops, and nurtures CD AV Training for LEA.
- 5. Assists in entering Case Management (CM) Mission Data.
- Assists in updating aviation publications and mission "GO BAGS".
- Assist to execute flights assigned by AASF SAAO.
- 8. Aviator will be assigned additional duties to include but not limited to: Operational planning, staffing, counterdrug presentations, program management, and safety duties.

*Drug screening will be completed prior to entry on active duty.
