SECTION III: Qualification Requirements (To be considered for this position, individual must possess or initiate a National Agency Check with Inquiries (NACI) background investigation. A <u>favorable</u> determination based upon investigative results is mandatory for this position. Failure to meet these requirements will result in termination of employment.)

Minimum grade E1; maximum grade E5. Applicant must have strong observational, analytical, and communication skills, ability to operate in rural/field environments for extended periods, proficiency in reconnaissance, tactical expertise, and GPS equipment. Must not be under any current Suspension of Favorable Personnel Actions (FLAGS). Applicant must maintain appropriate level of physical readiness and pass the appropriate service fitness test IAW service regulations. Must have a valid state issued driver's license. Must have an Army issued driver's license or be able to obtain one by the start of the duty position. Must have a non-expired Government Travel Card (GTC) or be able to obtain one by the start date of the position. The Soldier must not have served on any combination of operational support orders for more than three years out of the preceding four years. Applicant must not serve more than 17 years of Active Federal Service as a result of this duty. The Soldier must not be able to qualify for sanctuary as a result of the duty unless a waiver is approved prior to the publication of the order. Selectee will be required to pass a drug test within 30 days of starting position. Must have a current (i.e., completed within the last 12 months) physical health assessment (PHA) and no IMR deficiencies. Soldiers with any unresolved medical issues, to include temporary profiles, are ineligible for a tour. Must have a current negative HIV-1 test within 2 years of the projected report date.

SECTION IV: Placement Factors

Applicants should demonstrate through prior experience, education, and training the following:

- A. Ability to utilize geospatial and mapping utilities for terrain analysis and mission planning.
- B. Ability to create and interpret graphs, charts, and topographic maps to support reconnaissance and observation operations and threat assessments.
- C. Ability to liaison effectively with analysts, operational units, and interagency partners to coordinate reconnaissance and observation efforts and share actionable information.
- D. Completion of Ground Reconnaissance Phase I Course within 6 months of acceptance of CD orders.
- E. Possess a favorable National Agency Check (NAC) and be able to obtain a Secret security clearance for duty position of assignment.
- F. Ability to obtain minimum M17 qualification of "Sharpshooter".

Selectee may be subject to uncommon tours of duty, recall to the workplace, and irregular hours. Shift work may be required. Selectee will be required to attend Individual Drill Training (IDT)/Annual Training (AT) periods while on this tour. Must meet medical retention standards. Permanent Change of Station (PCS) funding for duty greater than 139 days is subject to approval by the respective program manager.

SECTION V: Summary Of Duties

The Ground Reconnaissance Specialist is responsible for conducting observation and reconnaissance operations in support of requesting law enforcement agencies (LEA). This support includes monitoring areas of interest, identifying known and potential subjects/threats, and documenting activity in support of operational objectives. The member will utilize camera equipment—such as still photography, video recording (without audio), and night vision optics—to capture and preserve visual records for the LEA. Operations are conducted in both rural and urban environments, often under varying and challenging weather conditions including heat, cold, rain, and limited visibility. Duties include maintaining detailed observation logs, producing visual data, and coordinating with LEAs, and other relevant entities to ensure timely and accurate reporting for enhanced situational awareness. The position requires discretion, adaptability, and sustained alertness during extended field operations in diverse and often austere conditions. M17 "Sharpshooter" qualification is required to ensure readiness and safety during assigned missions.
