## **LEGAL ASSISTANCE FOR SERVICEMEMBERS, THEIR DEPENDENTS, DISABLE VETERANS, AND RETIREES**

Welcome to the Office of Legal Assistance. All Legal Assistance services are provided to all Armed Forces Servicemembers, their dependents, retirees, and qualifying disabled veterans. You may contact the Legal Assistance office at 501-212-5040 or at the email and legal assistance website listed above.

### **LEGAL ASSISTANCE SERVICES PROVIDED**

#### **Preparation of documents:**

Wills with or without Trust language, Living Wills, Advance Medical Directives/Proxy, Powers of Attorney, Beneficiary Deeds, and Affidavits of Paternity.

#### **Notary Services**

#### **Legal Counseling:**

Estate planning, Last Will and Testament, Living Will, Healthcare Designations, Powers of Attorney (Special, General and Durable, including Childcare powers of attorney).

Family matters such as adoption, paternity, divorce, custody, support, and visitation including developing adequate Family Care Plans.

Consumer issues such as contracts, auto repairs, warranties and bankruptcy.

Landlord-Tenant issues.

Real property law such as home purchase or sale (review of contracts).

Servicemembers' Civil Relief Act rights (SCRA).

Naturalization (packet review prior to submission).

Referral to civilian attorney for complex legal matters (civilian attorney referral list or pro bono legal services).

**Services Not Provided:** The following services are not provided by AR ARNG Office of Legal Assistance but may be referred to another agency depending on the circumstances.

Representation in any court.

Private business activities, including rental ownership issues.

Litigation or claims against any government entity.

Prepaid-legal-representation cases, such as your insurance company defending you in a case.

Contingent fee cases.

Standards of conduct issues.

Legal issues or concerns raised on behalf of a person who is ineligible for legal assistance.

Disability Evaluation.

Discharge upgrade and correction of military records.

Employment matters, except issues relating to the Uniformed Services Employment and Reemployment Rights Act (USERRA).
