## **Pro Bono Resources for Veterans**

The Arkansas Legal Services Partnership – Center for Legal Services and Legal Aid of Arkansas, provides free legal aid services to eligible individuals. General eligibility is based on income and resource levels. Services include, but are not limited to, civil litigation, family law, public benefits, consumer law, foreclosure, and landlord/tenant issues.

The Arkansas Legal Services Partnership operates a Veterans Legal Assistance Program at the CAVHS Veterans Day Treatment Center located at 1000 South Main Street, Little Rock, Arkansas 72201, Tel: 501-244-1900. Interested veterans should complete an online application at www.arlegalservices.org to determine if they are eligible for free legal aid services. Appointments are made with eligible veterans between 9:30 a.m. and 11:30 a.m. on the third Tuesday of every month.
